The Center offers a job skill training program for individuals to learn different skills which help them to advance their abilities to do more complex work and gain new skills.



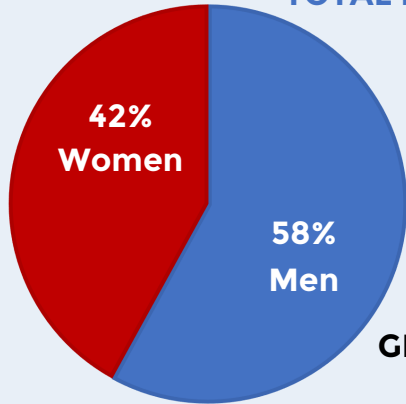




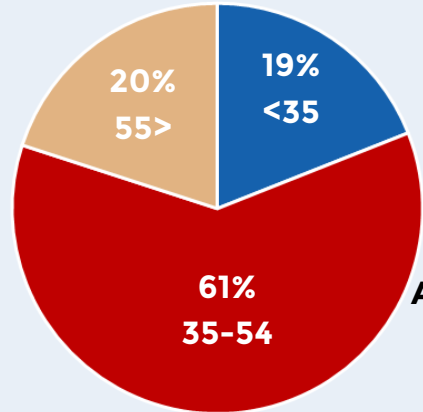

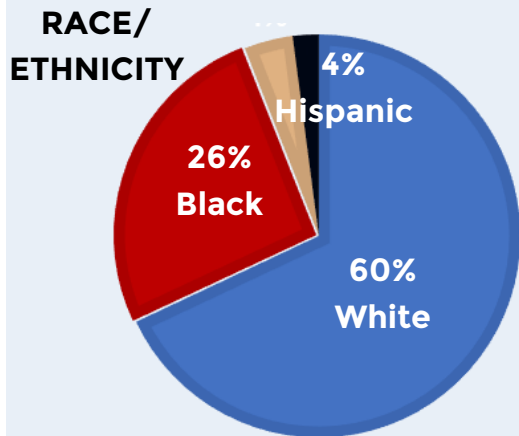

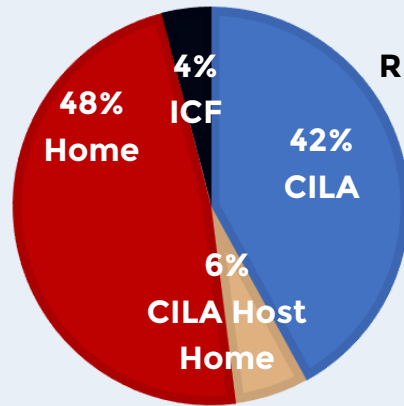
