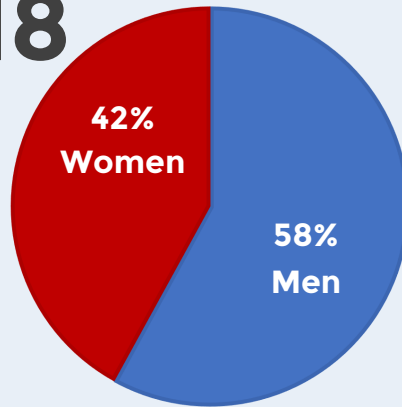

Help individuals with developmental disabilities reach personal goals through individualized skill development, vocational opportunities, and community service.

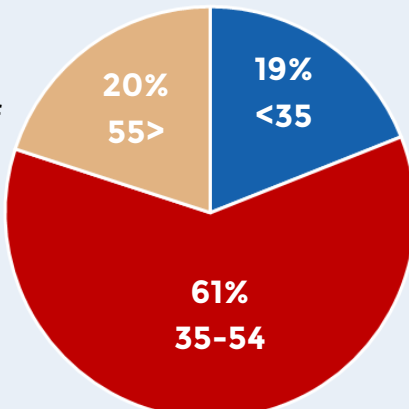

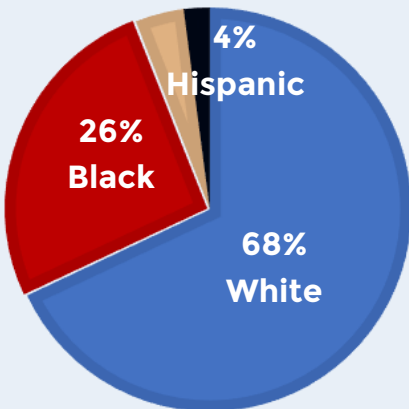


GENDER
